About GCERF

GCERF is the first global fund to support community-level initiatives aimed at strengthening resilience against violent extremism. As a public-private partnership operating at the nexus of security and development, GCERF works in partnership and consultation with governments, civil society, and the private sector in partner countries. We support national strategies to address local drivers of violent extremism.

GCERF provides support to community-level initiatives that provide tangible, positive alternatives to violent extremist groups` offer. We also build the capacity of civil society organisations and governance actors to prevent violent extremist group recruitment and radicalisation.

GCERF began its first investments in 2016 in Bangladesh, Mali and Nigeria. We have expanded our support to 25 countries, partnering with over 380 local civil society organisations and reached nearly four million people at risk of radicalisation and recruitment.

Description of Services

Background

GCERF started its engagement with the Permanent Representative of Tajikistan (2023) to the United Nations in Geneva. The Tajikistan governments invited GCERF for an introductory meeting in the capital city of Dushanbe in July 2024. Rounds of official meetings concluded with a formal partnership between GCERF and the General Prosecutor's Office of the Republic of Tajikistan, as the leading body coordinating the activities of state bodies, civil society institutions and international organisations in implementing the Strategy for Countering Extremism and Terrorism in the Republic of Tajikistan. GCERF Governing Board approved Tajikistan to become a partner country in September 2024 requesting the GCERF Secretariat to manage the process of the Republic of Tajikistan joining the Board and developing a Country Support Mechanism for Tajikistan.

In this regard, additional information is needed to explore specific areas of need for GCERF support. GCERF is therefore intends to launch a Country Needs Assessment for Tajikistan to better understand the drivers, actors, resources, requirements and risks relevant to funding programming related to rehabilitation and reintegration of returnees, and prevention of violent extremism in Tajikistan. This must include specific focus on the challenges of operating in the proposed geographic areas in relation to this topic and issues to consider such as rehabilitation, re-socialisation and re-integration of the family members of the former members of ISIS who have

been returned by enabling community-based integration. The assessment also explores potential support for labour migrants that may be at-risk of radicalisation. The terms of reference outline GCERF's requirements and preferred approach.

Objective

GCERF is looking for a supplier **based in Tajikistan** to deliver a Country Needs Assessment (CNA). The assessment should focus geographically on areas where violent extremism poses threats first of all, and the specific locations/communities where returnees resettled.

The NA has three objectives:

- 1. Identify opportunities to support civil society organisations working on rehabilitation, re-socialisation and reintegration of people returning from Syria and Iraq in Tajikistan with special focus on women and children.
- 2. Identify opportunities to support civil society organisations to implement programming that reduces radicalization and recruitment in to violent extremist groups with specific focus on labour migrants.
- 3. Identify opportunities for technical and practical support for the Secretariat to implement the Strategy for countering extremism and terrorism in the Republic of Tajikistan.

The assessment will include a literature review, in-country research, and the production of a final analytical report with clear recommendations for GCERF programming. The analysis will cover the following areas:

Objective 1: Identify opportunities to support civil society organisations working on rehabilitation, re-socialisation and reintegration (R&R) of people returning from Syria, Iraq and Afghanistan in Tajikistan with special focus on women and children.

- An analysis of the main actors and stakeholders currently working on reintegration, highlighting their agendas, motivations, and their capacity to influence dynamics, both positively and negatively;
- An assessment of trends and potential scenarios in the context of national and regional fragilities;
- An assessment of ongoing support and existing structures as well as needs not currently covered by the government, bi-laterals, and civil society organizations.
- Identify opportunities (short and long term) to support civil society organisations working on R&R of people returning from Syria and Iraq with special focus on women and children;

- Identify areas on how the role of women, women's civil society organizations and women activists in cities and districts of the country to prevent extremism can be enhanced;
- Identify opportunities how legal literacy activities for women and girls in collaboration with civil society can be promoted;
- Studying the risks associated with working with returned women and children, as well as improving the skills of those responsible for working with this category;
- Identify possible preventive activities with returnees with the involvement of clergy, psychologists and other specialists.

Objective 2: Identify opportunities for programmatic interventions to prevent violent extremism with specific focus on labour migrants.

- A mapping of relevant national, regional, international organizations in Tajikistan in preventing and countering violent extremism programmes, describing their scope, reach, and partners, including funding sources where possible;
- Examine the activities carried out by the advisory groups established in pilot districts to identify their needs and value proposition for future support;
- An identification of gaps and niche intervention areas for supporting community-led prevention efforts in radicalization and violent extremism where GCERF can add value in the current context with specific focus on labour migrants;
- A detailed assessment of risks and operating challenges in the suggested geographic areas and any other issues to consider;
- Identify entry-points on how to promote awareness of violent extremism prevention among labor migrants;
- Identify opportunities for facilitating capacity-building of government officials in the field of preventing violent extremism, rehabilitation and reintegration of returnees, in cooperation with other international organizations, civil society institutions and stakeholders;
- Assess possibilities on to promote the capacity of the local communities to prevent violent extremism at early stages.

Objective 3: Identify opportunities for technical and practical support for the Secretariat to implement the Strategy for countering extremism and terrorism in the Republic of Tajikistan.

- Assess ways to improve the effectiveness of measures to prevent extremism and terrorism;
- Research about the most effective ways of community awareness and engagement of individuals committed to extremism
- Assess the most efficient way of use of mass media in raising awareness about prevention of violent extremism

 Assess the availability of teachers' capacity in higher education institutions on issues of countering extremism and terrorism and the availability of training modules.

Work to be performed and deliverables

The overall approach will involve the participation of the Independent Review Panel (IRP), and it will include the following stages and components:

Phase 1: Literature Review – 14 March, 2025

The supplier will undertake desk-based research to bring together findings of the existing studies on this type of programming in these areas (The review should also include reports from government agencies and civil society organizations that are working on P/CVE and R&R areas). The assessment should be forward looking.

The supplier will also consult with relevant state and non-state institutions to identify potential geographic focus locations for PVE and R&R.

The research partner is expected to submit a research plan for discussion and validation by the end of this phase. The plan is expected to reflect a wide range of possible risks in a risk assessment annex.

Phase 2: In-country Research – 28 March, 2025

The in-country research phase will include consultation with relevant stakeholders, national partners, entities, CSOs, groups, UN and other donors in the country.

1. Partner Consultation: Fieldwork

The research team should undertake a series of interviews with individuals and partners in the following categories:

- Relevant local, provincial and national government officials;
- Civil Society Organisations, including customary authorities;
- National and International Research Organisations;
- Relevant regional stakeholders in Central Asia;
- Relevant local, provincial and national business entities to gauge their perspective;
- International Partners, including multilaterals such as the United Nations, OSCE.

2. Community Focus Groups

The provider should conduct community focus groups in the agreed locations that would be relevant for PVE interventions and RRR. This phase may also involve qualitative assessments with stakeholders in target locations to triangulate preliminary findings and identify priority issues, including informal interviews with returnees, guardians of children who have been returned and other relevant beneficiaries.

Phase 3: Research Outputs – 15 April 2025

- **Consultation on Findings:** Before drafting the final report, the team will share the draft consolidated findings and recommendations to GCERF. The team will adjust the report in line with the feedback provided.
- Raw data and final report: The report should analyse (1) the dynamics of vulnerabilities to violent extremist groups, and (2) identify opportunities for programmatic interventions, with details of ongoing efforts in these areas as outlined above. The final report should be provided in English with the raw data. In addition, the supplier needs to provide a succinct, two-page executive summary with key recommendations and power point presentation for dissemination in English and Tajik.

Requirements & Characteristics of the provider

The provider must comply with all applicable laws and regulations of the Republic of Tajikistan and Switzerland. It should adhere to a strict confidentiality policy in relation to client (GCERF) information.

Its staffing levels, qualifications and expertise should be appropriate to be able to provide timely and high-quality services to GCERF. The provider should demonstrate a high degree of commitment to good customer service. The composition of the team servicing GCERF's account would be an important factor in the decision-making process of GCERF.

The fees charged should be reasonable, competitive and related to services rendered to the extent possible.

1. Required Expertise:

- Demonstrable in-depth knowledge of the context and dynamics in Tajikistan;
- Relevant expertise in political and security analysis and actor mapping;

- A developed network of contacts in Tajikistan, including within the government and the international community;
- Physical presence in Tajikistan;
- Ability to demonstrate reflexivity in research design and delivery;
- Ability to analyse and interpret findings and results in a manner that informs strategies and policies;
- Experience working in fragile and conflict affected contexts on prevention programming;
- Fluency in both spoken and written English and local languages.
- 2. **Governance & Management:** GCERF Secretariat will oversee the work of the supplier. GCERF Head of Programmes will be the main point of contact for this contract.
- 3. **Timeframe:** The proposed timeframe for this workstream is 3 months, to conclude on 30 April 2025. There is a possibility to extend to delivery period to an additional 2 weeks maximum provided the request is made at least 3 weeks before the deadline.
- 4. **Funding:** The supplier will generate and propose an Activity Based Budget for the task and manage the financial delivery with support from a dedicated GCERF's Finance point of contact.

Submission of proposals

Proposals should follow the template provided below. Failure to follow the proposal structure or to comply with the instructions in this Request for Proposal will be at the bidder's risk and may affect the evaluation of the proposal.

Proposals should be submitted by email in the form of "pdf files" clearly marked "Bid reference: RFP 2025-03 CNA in Tajikistan". The email should be addressed to bids@gcerf.org.

Deadline for submission is 15 February 2025 midnight Central European Time.

Period of validity of the proposal

The proposal must be valid for a period of 120 days following submission.

Cost of preparation and submission of the proposal

The bidder shall bear all costs associated with the preparation and submission of the proposal, including but not limited to the possible cost of discussing the proposal with GCERF, making a presentation, negotiating a contract and any related travel. GCERF will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the selection process.

Selection of bidders

Bidders are requested to provide the most appropriate and most cost-effective solution to meet the requirements.

The selection will be made based on a number of criteria that will be applied systematically to all bids received:

- Responsiveness to request;
- Proposed approach and detailed methodology;
- Qualifications, experience and composition of the team;
- Credibility of the bidder organisation;
- Quality of the offer document; and
- Financial Offer.
